I am directed to state that the Board of Governors, Medical Council of India at its meeting held on 03.09.2013 considered the assessment report (August, 2013) on the standard of examination and other teaching facilities available at Amrita School of Medicine, AIMS, Kochi for Recognition of M.Ch.(Plastic & Reconstructive Surgery) qualification granted by the Amrita Vishwa Vidyapeetham University and it was decided as under:-

"The Board of Governors considered the assessment report (August, 2013) and decided to recommend that M.Ch.(Plastic & Reconstructive Surgery) qualification granted by Amrita Vishwa Vidyapeetham University in respect of students being trained at Amrita School of Medicine, AIMS, Kochi be recognized and included in the 1st Schedule to the L.M.C. Act, 1956 restricting the number of admissions to 02(Two) student(s) per year."

The attention of the institute is drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

- 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.

You are requested to issue notification recognizing the above qualification on or after August, 2013.

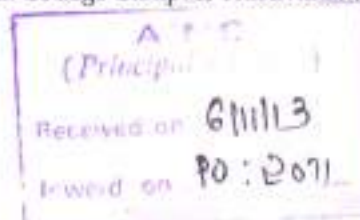
