I am to state that the General Body of this Council at its meeting held on 26-27/03/2015 considered the Council Assessor's Report (28-29.04.2014) on the physical and other teaching facilities available at Amrita School of Medicine, AIMS, Kochi for the award of MD(Social & Preventive Medicine / Community Medicine) qualification under Amrita Vishwa Vidyapeetham University. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

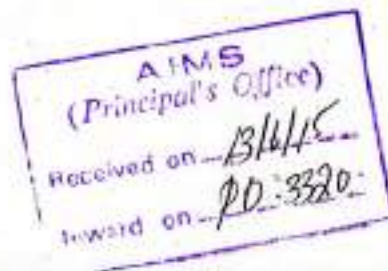
"The Postgraduate Committee considered the Council assessor's report (28-29.04.2014) and decided to recommend that MD(Social & Preventive Medicine / Community Medicine) qualification granted by Amrita Vishwa Vidyapeetham University in respect of students being trained at Amrita School of Medicine, AIMS, Kochi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 for 2 (Two) seats per year.

The Postgraduate Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of notification upon which the institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the postgraduate course."

You are therefore requested to notify the above qualification at the earliest.
