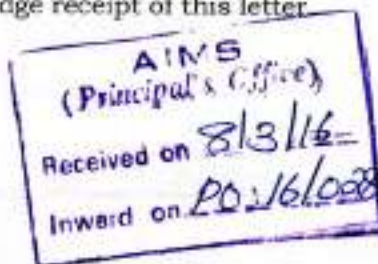

I am to state that the General Body of this Council at its meeting held on 26-27/03/2015 considered the Council Assessor's Report (April, 2014) on the physical and other teaching facilities available at Amrita School of Medicine, AIMS, Kochi, Kerala for the award of MD(Pathology) qualification for 02 seats under Amrita Vishwa Vidyapeetham University. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Assessment Report (April, 2014) and decided to recommend that MD (Pathology) qualification granted by Amrita Vishwa Vidyapeetham University in respect of students being trained at Amrita School of Medicine, AIMS, Kochi, Kerala be recognized for 02 (Two) seats and included in the 1st Schedule to the I.M.C. Act, 1956.

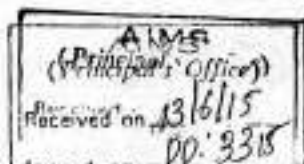
