"The Board of Governors considered the assessment report (May, 2013) and decided to recommend that MD(Physical Medicine & Rehabilitation) qualification granted by Amrita Vishwa Vidyapeetham University in respect of students being trained at Amrita School of Medicine, AIMS, Kochi be recognized and included in the 1st Schedule to the I.M.C. - 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.
