

The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Committee considered the assessment report (14.04.2014) and decided to recommend that MD(Radiotherapy) qualification for 2(Two) seats granted by Amrita Vishwa Vidyapeetham University in respect of students being trained at Amrita School of Medicine, AIMS, Kochi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.


