

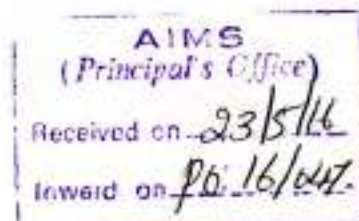

Sir,

It is stated that assessment report (May, 2011) on the standard of examination and other teaching facilities available at Amrita School of Medicine, Kochi for purpose of recognition of MS(ENT) qualification granted by Amrita Vishwa Vidyapeetham, Coimbatore was considered by the Board of Governors and it was decided as under:-

The Board of Governors considered the assessment report (May, 2011) and the recommendation of the postgraduate committee and decided that MS(ENT) qualification granted by Amrita Vishwa Vidyapeetham, Coimbatore in respect of students being trained at Amrita School of Medicine, Kochi be recognized and included in the 1st Schedule to the L.M.C. Act, 1956 restricting the number of admissions to 1(One) student per year.

The Board of Governors further decided that the attention of the institute be drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

- 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.

You are requested to notify the above qualification at the earliest.



I am to state that the General Body of this Council at its meeting held on 30/03/2016 considered the Compliance Verification Assessment (22/02/2016) along with the Council Assessor's report (April, 2015) and compliance dated 14/09/2015 submitted by the college authorities on the standard of examination and other teaching facilities available at Amrita School of Medicine, AIMS, Kochi for purpose of Recognition of MS(ENT) qualification against increased intake from 01 to 03 seats granted by Amrita Vishwa Vidyapeetham University.

The Council approved the following recommendations of the Postgraduate Committee which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment (22/02/2016) along with the Council Assessor's Report (April, 2015) and compliance dated 14/09/2015 submitted by the college authorities and decided to recommend to the Central Government that MS(ENT) qualification against increased intake from 01 to 03 seats granted by Amrita Vishwa Vidyapeetham University in respect of students being trained at Amrita School of Medicine, AIMS, Kochi be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
